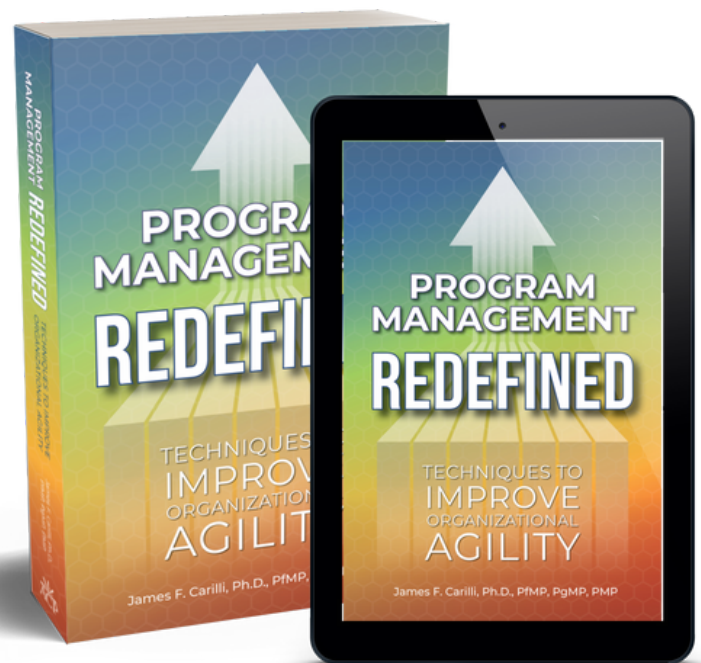

Jim's expertise in the management arena has been utilized in his role as a subject matter expert reviewer for two of PMI's ANSI-accredited peer-reviewed foundational standards, including The Standard for Program Management, fourth edition, PMI (2017), and A Guide to the Project Management Body of Knowledge (PMBOK Guide), sixth edition (2017). Jim helped lead the development of the first edition of PMI's Requirements Management: A Practice Guide (2016) as the vice chairperson and a contributing author. Earlier, in 2013, Jim served as a core team member and contributing author for a significant update to the third edition of The Standard for Program Management. He also served as a reviewer for The PMBOK Guide, fifth edition (2013), and The Standard for Portfolio Management, third edition, PMI (2012).

Jim has been a contributing author for multiple peer-reviewed publications, including those published by the *Academy of Human Resource Development*, *Scrum Alliance*, and *Project Management Institute's Annual Global Congress*. As a guest lecturer at the American University, Kogod School of Management, Jim has addressed MBA students on program management, project management, and agile methods and practices.

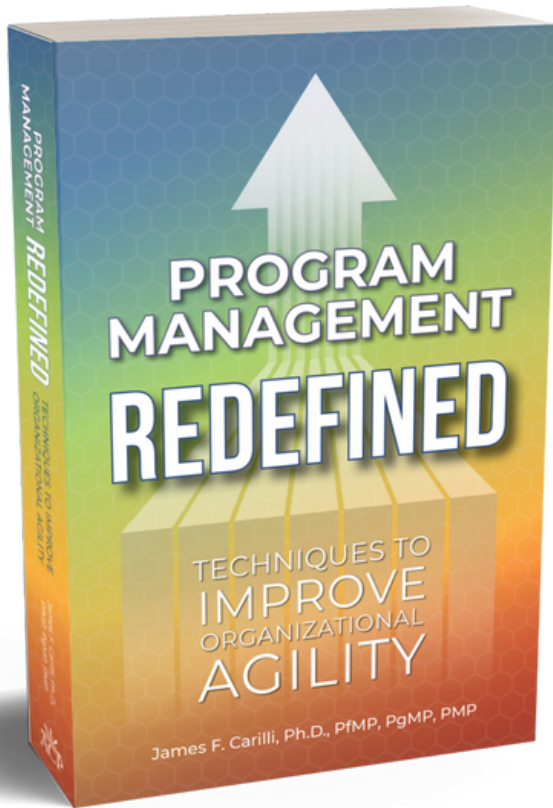

Q & A with the author, Jim Carilli, Ph.D.

What was your inspiration for *Program Management Redefined*?

There were a number of influences in deciding to write this book. My quest to write this book was initially founded in my support of the profession by volunteering for several Global standards efforts as a Vice-Chair, Committee Member, Contributing Author, and Subject Matter Expert Reviewer. I would say jokingly “one day I’ll have my name on the front of the book instead of in the back of the book.” I’ve made knowledge sharing a principle part of my professional life by presenting research and perspectives at academic and professional conferences, serving as a guest lecturer for MBA students, mentoring those starting their careers in project and program management, and training and coordinating training for scores of professionals seeking industry certifications. I receive so much satisfaction and learning by sharing information and helping train new employees. Finally, this book represents an opportunity to give back to the profession by reaching a much wider audience to share techniques that redefine Program Management as a set of practices to support governance, strategic alignment, and delivery with Lean/Agile methods to improve overall organizational agility.

How does this fill a gap in the available information for people to successfully lead their teams?

The inspiration for this specific topic and title was based on looking at how much Agile practices have changed other disciplines (e.g. Software Development, Project Management, etc.) and seeing very little guidance for Program Managers to follow to apply the principles to their profession. The book provides specific techniques to increase agility in program management practices that include: Communications, Quality, OCM, Resource Management, Risk Management, Information Management, and Learning and Development.

What experiences did you draw from to create this book?

In my 30+ years of helping global organizations with complex projects and programs, I have been very fortunate to have opportunities, mentors, and experiences that helped shape the content of this book. With that said, I did not solely reference my experience in writing this book. I shared the manuscript with my network from the business and academic communities and reviewed several case studies, recently published books, articles, journal papers, conference proceedings, videos, and other media prior to publishing.

Q & A with the author, Jim Carilli, Ph.D.

Can you talk a little about the concept and importance of agility for program and project management?

Organizational agility enables an organization to sense (identify, qualify, quantify) opportunities, respond (by internally assessing and prioritizing) and deliver (through flexible structures) those changes deemed highest priority by their customer base.

Agility for programs considers fusing organizational competency, market and stakeholder understanding, strategic alignment and responsiveness; structural flexibility and learning and adaptability.

The outcomes of applying these practices yield:

- Improved alignment;
- Enhanced visibility of work-in-progress;
- Improved stakeholder collaboration;
- Managed organizational risks;
- Increased efficiency;
- Increased agility;
- Reduced costs; and
- Improved Return on Investment (ROI).

Who is this book for? Why will it be helpful to them?

This book was primarily written for those currently serving in program management roles or those who aspire to enter the profession. For both audiences, the content is intended to provide a new way of thinking about programs through the lenses of organizational agility and simplified, yet comprehensive, practice areas and guiding principles. The Program Delivery Framework provides a structure for solutions through the integration of practices and interactions with key stakeholders.

Portfolio Managers, Program Sponsors, Program Steering Committee members, and Senior Business and IT leadership may benefit from this book to gain knowledge regarding:

- Assessing the business case for the investment in program management and promoting the benefits of program management.
- Identifying opportunities to deploy program management teams to support the delivery of strategic business objectives.
- Providing support and guidance to program management teams.
- Evaluating potential candidates for upcoming program management opportunities or when assigning additional responsibilities.
- Understanding the program roles and competencies to offer learning and development opportunities to those who aspire to program management roles.

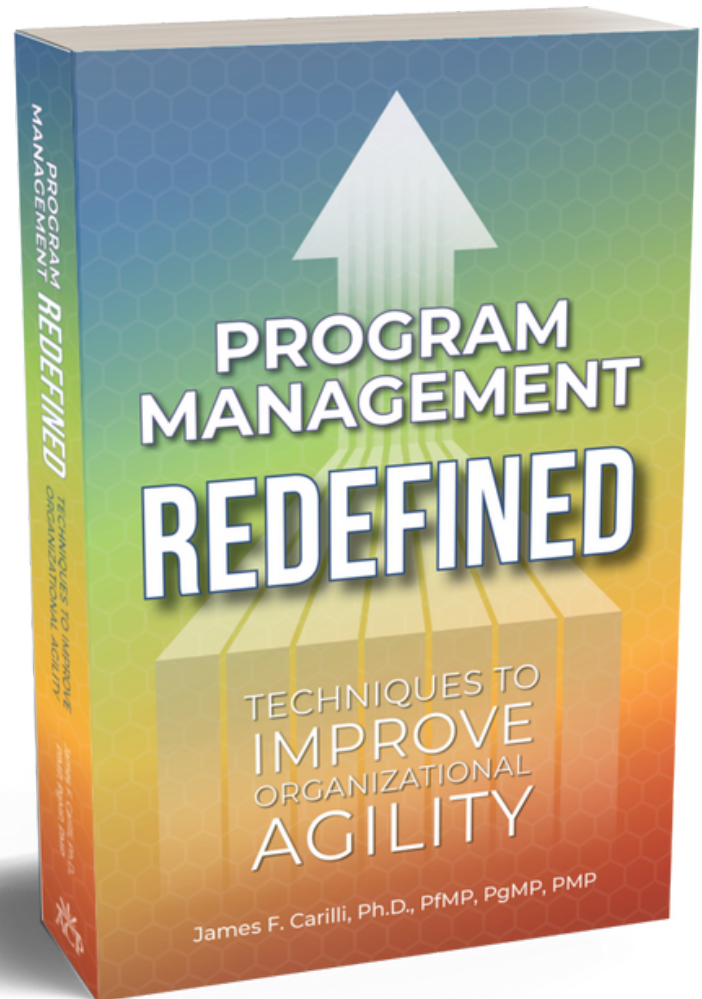
